



URGENT MEDICAL DEVICE RECALL

September 1, 2020

Dear Customer:

This is to inform you of a product recall involving:

30-0171 NAR RESPONDER 4" FLAT EMERGENCY TRAUMA DRESSING LOT TSD3819 AND LOT TSD0320

30-0171 IS A COMPONENT OF THE FIRST AID KITS IDENTIFIED IN ENCLOSURE 2

See enclosed 1 product label for ease in identifying the product at user level.

North American Rescue (NAR) is voluntarily recalling product 30-0171 Lot TSD3819 and Lot TSD0320. We are recalling these products due to a manufacturing deviation which resulted in a lack of the assurance in the sterility of the 30-0171.

Affected product was shipped between December 23, 2019 and August 3, 2020. This product was shipped individually and in kits (affected kit product codes are listed below). Included is a list of affected product and kit lot numbers, listed by product code (see Enclosure 2).

Immediately:

1. **Examine** your inventory and quarantine all product and kits identified in this recall notification, refer to enclosure 2.
2. **Discontinue** all distribution or use of the recalled products identified in this recall notification.
3. **Identify** the 30-0171, with the aid of enclosure 1, and verify the recalled lot TSD3819 or TSD0320.
4. **Remove** the recalled lot TSD3819 or TSD0320 from the kit and quarantine.
5. **Contact** NAR Customer Service toll free at 1-888-689-6277 to receive a replacement and arrange for the return of the recalled lots. (Please have your customer order number available to reference.)

This recall should be carried out to the user level. Your assistance is appreciated and necessary to prevent patient harm. If you have further distributed this product, please:

1. Identify your customers and immediately notify them of this product recall. Your notification to your customers may be enhanced by including a copy of this recall notification letter.
